



Straight River Days Rubber Duck Pluck

Presented by the Medford Civic Club (the “Presenter”), to benefit Straight River Days and other local community events.

1. Ducks will be dropped into the Medford Swimming Pool located at 205 2nd Ave NW Medford, MN at 3:00 PM on Saturday, June 20, 2026. Chances of winning depend on the total number of qualified entries. A maximum of 500 ducks will be entered in to the pool.
2. The 2026 Straight River Days Rubber Duck Pluck shall be open to legal residents of the United States who are at least 18 years of age (Entrant). Prize winners must be individuals at least 18 years or older, or a parent, or guardian must accept the prize. Winners must show proper identification when claiming prizes. The prizes may not be substituted or exchanged.
3. The price to enter and to purchase an entry ticket(s) are as follows: single duck (1) for \$5.00.
4. All ducks entered will be provided by and shall remain the property of the Presenter.
5. Once the ducks are dropped, they are on their own. No attempt to interfere with and duck is permitted, unless deemed necessary by the Committee.
6. A number will be written on each duck corresponding directly to the number on the entry ticket. Multiple duck entries will be assigned a different duck identification number for each duck entry. Prize(s) will be awarded to the person whose name appears on the entry ticket in the order the corresponding ducks were plucked from the water.
7. The 1st place winner will receive \$300.00. The 2nd place winner will receive \$200.00. The 3rd place winner will receive \$100.00. The 4th place winner will receive \$75.00. The 5th place winner will receive \$50.00. The 6th place winner will receive \$20.00. The 7th place winner will receive \$20.00. The 8th place winner will receive \$20.00. The 9th place winner will receive \$20.00. The 10th place winner will receive \$20.00.
8. The entry portion of each ticket must be completely filled out and delivered to the Presenter, or an authorized representative of the Presenter for a ticket to be eligible to win any prize. No other tickets are eligible to win any prize. For multiple duck entry sales, a separate entry ticket must be completed for each duck. Entrants assume the risk of non-delivery of any entries to Presenter or an authorized representative of Presenter.
9. Winners will be announced following the duck pluck – on location – Saturday, June 20th, 2026. Entrants will, where necessary, also be notified by United States mail, email, or telephone within 5 days of the Rubber Duck Pluck. Race winners need not be present to win. A list of winner(s) can be obtained from the Presenter by sending a written request and a self-addressed, stamped return envelope to Presenter at PO Box 25, Medford, MN 55049. If any winner(s) does not claim his or her prize from the agency within thirty (30) days after June 20th, 2026, the prizes will be forfeited and returned to the donating organization and/or used for the lawful purpose in the sole and absolute discretion of the Presenter.
10. Individual ticket purchases are not tax deductible according to the United States Internal Revenue Service.
11. By entering, entrants release the Presenter and its members, directors, agents, employees, and other related entities from any and all liability with respect to prizes.

12. By entering, winners consent to promotional use of their names and likeness without additional compensation.
13. This event is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
14. Any and all federal, state, and local taxes and fees on prizes are the sole responsibility of the winner.
15. All decisions and interpretations of rules, regulations and final determination of winners shall be made by Presenter and its judgment is final.
16. The Straight River Days Rubber Duck Pluck and its logo are registered trademarks of the presenter and no other person or entity is authorized to copy or otherwise use them without the Presenter's express written consent.
17. If the Presenter determines, in its sole discretion, that the duck pluck cannot occur at the scheduled date/time for any reason, then the Presenter can postpone the duck pluck to another date/time by public announcement thereof. The Presenter shall not be held liable for any loss, damage, or inconvenience which may result by any such postponement or rescheduling of the Straight River Days Rubber Duck Pluck.
18. Members of the Medford Civic Club Board of Directors and members of their family living in the same household are not eligible to win prizes. Winners have the burden to prove eligibility.
